This has reference to our disclosure dated February 04, 2025, regarding penalty demand order dated February 03, 2025 ("Demand Order") issued by the Central Goods and Service Tax (CGST) Department ("Authority") in relation to alleged non-compliance of provisions of the Central Goods and Services Tax Act, 2017.

We wish to inform you that pursuant to the appeal filed against the Demand Order, the Commissioner (Appeals), vide its order dated June 18, 2025 (received by the Company on June 23, 2025 at 6:30 PM (IST), has granted partial relief by modifying and reducing the penalty, as detailed in **Form A**. The Company, based on its internal assessment and expert legal advice, believes that the penalty demand is not maintainable and will be filing a further appeal against this order.
